Context

Schools are required under the Equality Act 2010 to have an accessibility plan. The purpose of the plan is to:

- > Increase the extent to which disabled pupils can participate in the curriculum
- > Improve the physical environment of the school to enable disabled pupils to take better advantage of education, benefits, facilities and services provided
- > Improve the availability of accessible information to disabled pupils

Our school aims to treat all its pupils fairly and with respect. This involves providing access and opportunities for all pupils without discrimination of any kind.

Bishop Milner Catholic College is a welcoming school where tolerance, honesty, co-operation and mutual respect for others are fostered. We believe that every student is made in the image of God and we are committed to the development of the whole person within a secure and creative environment which is supportive of the individual, regardless of their age, sex, race, colour, religion or disability. We aim to promote equality, tackle any form of discrimination and seek to remove any barriers to access, participation, progression, attainment and achievement. We take seriously our contribution towards community cohesion.

With this in mind this Accessibility Plan has been drawn up in consultation with the students, parents, staff and representatives of the college and covers the period from November 2022 – November 2025.

The Accessibility Plan will contain relevant actions to:

- Improved awareness of Equality and Inclusion.
- Improve access to the physical environment of the college, adding specialist facilities as necessary. This covers improvements to the physical environment of the college and physical aids to access education.
- Increase access to the curriculum for students with a disability, expanding the curriculum as necessary to ensure that students with a disability are as, equally, prepared for life as are the able-bodied students; (If a college fails to do this they are in breach of the Equality Act 2010). This covers teaching and learning and the wider curriculum of the college such as participation in after-college clubs, leisure and cultural activities or college visits. It also covers the provision of specialist aids and equipment, which may assist these students in accessing the curriculum.
- Improve the delivery of written information to students, staff, parents and visitors with disabilities. Examples might include handouts, timetables, textbooks and information about the college and college events. The information should be made available in various preferred formats within a reasonable time frame.
